











Data Governance and Transparency. Organization Chart 2019

Internal Capability Roadmap 2019-2023

State in 2019

- Chief Data Office built on siloed disparate programs
- Lack of clarity on Chief DataOfficer role and services at an enterprise level
- Geospatial data and enterprise data viewed as separate initiatives
- Open data capacity limited

Top Initiatives


- •Create a Data Team: Establish a team of technology generalists to enable data delivery and sharing capacity.
- •Reinvigorate Open Data and Transparency: Build and sustain the State's first Open Data Program, including creation of the first enterprise data inventory for the State.
- Bridge geospatial and non-spatial data communities: Building joint strategies between GIS and other data communities, centered on shared data governance outcomes
- ■Building for Data Policy: Identifying critical resource gaps and needs in building capacity and tools for data equity, data governance, and other policy areas
- ■Establishing Critical Roles: Building out service delivery and overall capabilities within the Chief Data Office

State in 2023

- Cohesive program focused on data delivery: curation, sharing, publication
- Service Catalog available for customers and constituents
- Geospatial data and enterprise data viewed as partners in shared initiatives
- Open data services enable agencies to streamline transparency



Building a Demand-Responsive Organization



Customer Request

Request is proposed and submitted to Program Manager for review and approval.

Prioritize

Use case is prioritized and added to portfolio.

Design

Solution is designed based upon stakeholder needs, technology skillset and identified outcomes.

Develop

Data Governance and Transparency staff develop solution.

Validate

Stakeholders provide validation of requirements and accept product.

Ship

Dataset, policy, storymap, application, product, etc. is shipped

- Building service catalog
- Piloting new data capabilities related to open data and data delivery

Externally:

- Updating Oregon Data Strategy Biennial Action Plan (2023-2025)
- Launching Statewide Data Governance Policy
- Expanding investment in Oregon Framework Program and geospatial data sharing
- Updating Strategic Plan for Geospatial Data Management (2023-2026)
